

South Sound Events Photo Booth Terms and Conditions

1 - Booking Confirmation

1.1 - A deposit must be made to secure the date of your photo booth booking.

1.2 - Upon payment of deposit, the hirer is agreeing to the Terms and Conditions.

1.3 - The booking is not confirmed until the hirer receives an email and/or invoice from South Sound Events as confirmation.

2 - Payments

2.1 - The deposit is non-refundable (or may be refunded at South Sound Events discretion), and must be paid upon booking. The booking is not confirmed until the deposit has been received and acknowledged by South Sound Events.

2.2 - The balance remaining must be paid 14 days before your event.

2.3 - If the balance of the booking cost has not been received more than 14 days before the event date, the booking will be cancelled and the client will forfeit the deposit.

2.4 - Cancellations less than 90 days from the event will be liable for payment in full, unless we are able to secure a booking for the photo booth. If we are able to rebook the booth, a full refund may be provided, however this is at the discretion of South Sound Events. A \$100 cancellation fee will always apply.

3 - Access, space and power requirements

- 3.1 - It is your responsibility to supply South Sound Events with the correct address details of the venue.
- 3.2 - Confirmation of the venue's approval and the placement of the photo booth within the venue, is the hiring client's responsibility.
- 3.3 - Delivery, set up and removal of the photo booth is included in your hire charge. The time taken to deliver, set up and remove the photo booth will be outside the rental period.
- 3.4 – The hirer is responsible for ensuring a safe and appropriate environment for South Sound Events to operate all equipment
- 3.5 - The hirer is responsible for ensuring there is access to a normal Australian 240v wall socket within 10 meters of the photo booth.
- 3.6 - The hirer is responsible for ensuring adequate space for the photo booth, 3 meters square at the very minimum.
- 3.7 - The hirer is responsible for ensuring a flat, dry area with shelter is available for the booth
- 3.8 - Doorways and access paths must at least 80 cm wide
- 3.9 - The photo booth cannot go up stairs
- 3.10 - A survey of the location may be required if South Sound Events are not satisfied that the location is going to be suitable. This may incur an additional fee of \$50 (within a 20km radius of Dunsborough).

4 - Indemnification

4.1 - South Sound Events agrees to have the photo booth operational for a minimum of 80% of the hire period, or a discount will apply. While replenishing ink and paper, the booth may or may not be shutdown for a period.

4.2 - We are not liable for failing to perform due to an event beyond our reasonable control, including power outage, failure by a service provided to us to perform, fire, threatened or actual act of terrorism, or a natural disaster.

4.3 - In the circumstance that we are prevented from attending your event - including but not limited to severe weather conditions, breakdown of our vehicle, severe sickness or hospitalisation, equipment failure – we will contact your venue and the contact person elected by you as soon as possible. We will endeavour to find a replacement, or to rectify the situation to allow the hire to commence as soon as possible. But should we be unable to attend - our liability will be limited to refunding all monies paid.

5 - Use Of Images

5.1 - We may use photos taken at your event on our website or social media pages, for the purposes of promoting our photo booth. You may request at any time, that your photos are not to be used for this purpose. We will not use images which are deemed unsuitable on our website or within our advertising – and we will not use any content that may be personally damaging to any person/s. We aim to send you the link to posted material so you can let us know if you approve.

6 - Damage To Equipment

6.1 - In order to prevent damage to equipment, South Sound Events reserves the right to deny service to any person/s.

6.2 - The photo booth may be stopped at anytime at the discretion of South Sound Events, if it is felt that the photo booth is being misused in a way that is dangerous to any persons, or potentially damaging to the booth. We reserve the right to refuse guests to participate if we feel they are too unruly or too intoxicated.

6.2 - The hirer is liable for all excess, premiums and other costs associated with any insurance claim in relation to the photo booth that arises from use by the hirer or their guests during the hire period. The hirer must meet any shortfall in repair or replacement of the photo booth following payment of any amount received under insurance, including any loss suffered by South Sound Events as a result of not being able to hire the photo booth after the hire period.
